ELIGIBILITY

For SR: MBBS with P.G. Degree/Diploma in the concerned specialty from a Recognized University/Institution and should be Registered with Delhi Medical Council.

For JR: MBBS degree from recognized university and should be registered with Delhi Medical Council.

Note

In case of non-availability of SR with in the prescribed age limit mentioned below, the age limit may be upto 40 years.

In case of non-availability of SR with in SC/ST/OBC category suitable General Category candidate may be selected.

In case of non availability of PG candidates, non PG. MBBS Candidates with two years experience, out of which one year should be in specialty, may be considered.


EMOLUMENTS

For SR, Rs. Pay Level-11 (Rs. 67700-208700), for JR Pay Level-10 (Rs. 56100-177500) + usual allowance as admissible under the rules.

AGE LIMIT: For SR, below 35 years, and For JR, below 30 year as on 30th September, 2017. Relaxable for SC/ST by 05 years and for OBC by 03 years (OBC candidates are required to submit their caste certificate issued by the Competent Authority of Govt. of NCT of Delhi).

RECRUITMENT CONDITIONS:

1. Other service conditions as prescribed from time to time by the Hospital will be applicable.
2. Their service will be governed by residency scheme.
3. Bring all Original Documents along with self attested Photocopies on the schedule date of Interview.
