## Annexure 'A'

## Qualifications and term and conditions

## **Essential Educational qualifications:**

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-graduate degree in the concerned Specialty or Super-specialty mentioned in Section-A of Schedule VI.
- (iii) At least three years' teaching experience as Senior Resident or Tutor or Demonstrator or Registrar in the concerned Specialty or Super-specialty in a recognized teaching institution after obtaining the first Post-graduate degree.
- (iv) The candidate must possess the requisite qualification as on date of interview.

### NOTE:

- 1. In the case of holders of Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) qualification of five years' duration, the period of senior Post Graduate residency rendered in the last part of the said of Doctorate of Medicine(D.M.) or Magister Chirurgiae (M.Ch.) shall be counted towards requirement of teaching experience.
- For recruitment to the post of Assistant Professor in the specialty of Clinical Hematology 'Doctorate of Medicine(Clinical Hematology); or Diplomat National Board(Clinical Hematology); or

## The terms and conditions for appointment of contract basis: -

- Remuneration: Ist year Rs. 95,000/- p.m. (consolidated), IInd year Rs. 1,05,000/p.m. (consolidated). The contractual appointee will not be benefits or concessions as admissible to Govt. employees. Income Tax will be deducted at source on monthly basis.
- 2. Age of Candidates should not be more than 40 years of age on the date of interview. Relaxation as per rules of Central Govt.
- 3. The contractual employment will be for a period of one year only or till regular incumbents join the hospital whichever is earlier. The services of the appointee are also terminable before expiry of the contractual period by either side after giving 30 days' notice or salary in lieu thereof.
