- 1. <u>Oualifications:-</u>MBBS degree from recognized University/Institute. Candidate must have not completed one year Junior Residency from any Govt. Hospital including(adhoc/regular).
- <u>Age Limit</u>-As on 30.05.2019 shall be 30 years for General candidates, 35 years in case of SC/ST and 33 years in case of OBC candidates (OBC certificate issued from Delhi only). In case fresh candidates are not available, in accordance of circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi the age limit shall be 40 yrs.

3. <u>Pay Scale:-Pay Matrix 10 of 7th CPC with Basic Pay of Rs. 56100 and other admissible allowances per month.</u>

4. Internship:-Candidates must have completed their internship on or before 30/05/2019 and the candidates having completed compulsory rotatory internship before 30/05/2017 shall not be eligible.

5. Must be registered with Delhi Medical Council.
