3. The above post is purely temporary, time bound and co-terminus with the project. Appointment will be yearly based on the progress and fund availability.
4. The selected candidate shall not claim for regular appointments at the Institute as the position is co-terminus with the project.
5. The Interview of eligible candidates will be held according to schedule given above.
