WALK-IN INTERVIEW

Applications on the plain paper are invited for the appointment of one General Duty Medical Officer (*on contractual basis*) in the Dr. M.A. Ansari Health Centre, Jamia Millia Islamia. The applicants are required to appear before the Interview Board on 19 Nov, 2019 at 11.30 Am in the **Committee Room, Office of the Registrar, Jamia Millia Islamia, Jamia Nagar, New Delhi – 110025.** Five copies of the bio-data mentioning educational qualifications, experience with a recent passport size photograph and attested copies of mark-sheets, degrees, diplomas, etc must be attached with the application. The contractual appointment will be made initially for a period of 180 days, extendable further based on performance or till further orders, whichever is earlier.

Qualification & Experience:-

- a. MBBS Degree from the recognised Medical College.
- b. Preferably having experience of working in causality for at least one year, should be able to diagnose and manage cases visiting the causality of Health Centre.
- c. Registration with MCI / Delhi Medical Council.

Age Limit:- Maximum 65 years of age as on the day of interview.

Duty Hours:- 4:00 PM to 10:00 PM. However, duties may be shifted in morning shifts / holiday / Sundays, if required.

Remuneration:- Rs. 60,000/- per month (fixed)

Note:-

1. Selection against contractual position shall not confer on the appointee any right of permanent appointment / regularization.
2. Ineligible candidates will not be permitted to attend the interview.
2. Candidate already in service must apply through proper channel.
3. Knowledge of Hindi and Urdu is a desirable qualification.
4. The University reserves the right to hold / not to hold Local Selection Committee for above post.
5. Canvassing, in any form or on behalf of the candidate, will be a disqualification.
