Qualification: MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University/Institution and should have a valid registration with Delhi Medical Council. Must not have completed 03 years Senior Residency in any recognized institution including regular & adhoc period.

Pay Scale: As per 7th CPC Pay matrix level 11, Pay Rs. 67700/ plus allowances as admissible under the rules.

<u>Age Limit:</u> 37 years for General, 5 years relaxable for SC/ST and 03 years for OBC candidates (belonging to Delhi only) on the closing date of submission of application.
