# Recruitment to the post of Chief Executive Officer (CEO) in National Pension System Trust (NPS Trust) on Deputation / Contract Basis

Pension Fund Regulatory and Development CHIEF EXECUTIVE OFFICER, NATIONAL Authority (PFRDA), is a statutory regulatory **PENSION** body established by an Act of Parliament, to DEPUTATION / CONTRACT BASIS promote, develop and regulate pension sector in India. PFRDA invites applications from No. of Posts: One (01) Indian citizens for filling one (01) post of Chief Executive Officer (CEO) in National Pension System Trust (NPS Trust) on deputation/ contract basis.

The NPS Trust is a distinct entity created by PFRDA as settler under the provisions of the Indian Trusts Act, 1882 to take care of assets and funds under the National Pension System (NPS). The NPS Trust is an adequately regulated and well administered intermediary under the provisions of PFRDA Act, 2013 and PFRDA (NPS Trust) Regulations, 2015 and it has been entrusted with the important responsibility of supervising all operational and service level parameters in respect of various intermediaries under the NPS architecture.

The CEO, NPS Trust is responsible for day-today administration and management of NPS Trust, subject to the superintendence, direction and control of the Board of Trustees of the NPS Trust. Presently, the office of NPS Trust is located in New Delhi. However, NPS Trust may, in future, open its office/ new regional offices anywhere in India and the CEO shall liable to be posted in such office. The post of The candidates appointed on deputation basis CEO, NPS Trust is outside PFRDA.

Scale of Pay:

As admissible to an Executive Director in PFRDA.

The present scale of pay for Executive Director in PFRDA is Rs.120500-3500(2)-127500 (3 years). Other benefits as admissible.

The monthly emoluments gross at the beginning the scale work out to Rs.3,05,000/approx. (without Housing Allowance) or Rs.3,80,000 approx. (with Housing Allowance).

# a) Qualification & Experience as on 31/08/2020:

Deputation from Govt. (All India/ Central Civil Service Group A), RBI, Banks, Financial Institutions, with not less than 20 years of experience in officer cadre in dealing with pension/ financial sector or special knowledge/ experience of law, investigation, finance, economics, accountancy, administration, fund Management or any other discipline considered useful to the NPS Trust.

# b) Desirable Experience:

Experience in Funds Management / Treasury Management / Portfolio Management / Investment.

#### Age Limit:

Not less than 45 years and not more than 55 years as on 31/08/2020.

## Term of appointment:

The appointment for the post will be on deputation for an initial period of three (03) years, extendable by a period of another two (02) years subject to satisfactory performance review.

The candidates applying for the post of Chief Executive Officer in NPS Trust on deputation basis should route their applications through their employer/ cadre controlling authority. Candidates applying on deputation basis should get their employer to furnish Vigilance Clearance (major/ minor penalties, if any, imposed during last 10 years) and Annual

Confidential Reports for last 5 years along with the application directly to PFRDA.

#### **ON CONTRACT:**

# a) Essential qualification & Experience as on 31/08/2020:

Post Graduation in any subject with a minimum of 20 years of post-qualification experience in officer cadre in dealing with pension/ financial sector or special knowledge/ experience of investigation, law, finance, economics. accountancy, administration. fund management any other discipline or considered useful to the NPS Trust.

## b) Desirable qualification as on 31/08/2020:

MBA/MMS with specialization in Finance/ CA / CS /CFA /CWA / LLB etc. from a recognized University/ Institution.

# c) Desirable Experience:

Experience in Funds Management/ Treasury Management/ Portfolio Management/ Investment.

# Age Limit:

Not less than 45 years and not more than 60 years as on 31/08/2020.

## Term of appointment:

The appointment for the post will be on contract basis for a period of three (03) years, extendable thereafter for a period of another two (02) years subject to satisfactory performance review and mutual consent.

The contract can be terminated by either side by giving 3 months' notice or making payment



assigning any reasons therefor.

The candidates working in Government /Quasi Government/PSU shall furnish Vigilance Clearance (major/ minor penalties, if any, imposed during last 10 years) and Annual Confidential Reports for last 5 years along with the application directly to PFRDA.

## A) GENERAL INSTRUCTIONS:

- 1. Applications which are incomplete, or not prescribed date or received supporting documents in respect of age, educational qualification and experience etc., will not be considered and summarily rejected.
- 2. The candidate is required to submit a brief profile (not exceeding 3 pages regarding qualification, experience etc. along with the duly filled application. PFRDA reserved the right to call for additional documents from the candidates to validate their claim with regard to eligibility for the post by email/post. Failure to furnish the required documentary proof shall result disqualification of the candidature of the candidate.
- 3. Mode of Selection will be Interview. The Competent Authority reserves the right to modify the selection procedure, if deemed fit. Outstation candidates called for Interview will be reimbursed 'Y' Class Air 8. fare for the to and fro journey, subject to submission of necessary documentary evidence. In case, where outstation candidates travel by any mode other than air, such candidates shall be reimbursed II AC Rail Fare for attending the interview.

    - 7. The candidates applying for the post of Chief Executive Officer, NPS Trust (on contract) who are already in service of Quasi-Govt. Public Govt., Sector Undertakings/Banks, will have to produce a 'No Objection Certificate' from their employer, at the time of interview. Before appointment in NPS Trust, a proper discharge certificate from the employer shall have to be produced by the selected candidate. Such candidates shall also have to furnish Vigilance Clearance (major/ minor penalties, if any, imposed during last 10 years) and Annual Confidential Reports for last 5 years along with the application directly to PFRDA.

- 9. Merely fulfilling the eligibility conditions laid down in the advertisement as regards to qualifications and experience, would not automatically entitle any candidate to be called for the interview. The Competent Authority reserves the right to raise the standards minimum in respect qualification and experience in order to restrict the number and shortlist the candidates to be called for the Interview.
- 10. The Authority reserves the right to cancel this advertisement fully or partly on any grounds without assigning any reasons therefor.
- 11. Canvassing in any form will result in disqualification of the candidate.
- 12. If a candidate is not eligible or has knowingly or willfully furnished incorrect or false particulars or suppressed material information, his/her candidature will be liable to be cancelled at any stage of the selection. If the candidate qualifies in the selection process and subsequently it is found that he/she does not fulfill the eligibility criteria, his/her candidature will be cancelled, without prejudice to any other action which the Competent Authority may deem fit to take.
