I. COMPANY PROFILE

Bharat Petroleum Corporation Limited (BPCL) came into existence in 1976, by virtue of Burmah-Shell (Acquisition of Undertaking in India) Act, 1976 when the right, title and interest of Burmah-Shell Oil Storage & Distribution Company of India Ltd. was taken over by Government of India. Its main objective is to undertake refining and marketing of Petroleum products. BPCL is a Schedule A, Maharatna CPSE in Petroleum sector with the administrative jurisdiction of Ministry of Petroleum and Natural Gas. The company employed 11249 regular employees (Executives- 5939 & Non-executives- 5310) as on 31.03.2020.

The authorized and paid up capital of the Company was Rs. 2635 crores and Rs. 2169.25 crores respectively as on 31.03.2020.

Its Registered and Corporate office are at Mumbai, Maharashtra.

The shareholding of the Government of India in the company is 52.98%.

# **II. JOB DESCRIPTION AND RESPONSIBILITIES**

The Director (HR) is a member of the Board of Directors and reports to Chairman and Managing Director. He/She is overall in charge of coordinating and implementing Personnel & industrial relations policies, management functions, administrative control etc in the Corporation.

#### III. ELIGIBILITY

# 3. QUALIFICATION:

The Post Graduate Diploma or Degree in Personnel Management/ Human Resource Management or Masters in Business Administration (MBA)/ Post Graduate Diploma/ Programme in Management (PGDM/PGPM), from a recognised University/Institution, will be desirable.
